Emergency Ordinance No. 195/2005 regarding Environmental Protection in Romania, approved with modifications and completions through Law No. 265/2006. It establishes a comprehensive legal framework for environmental protection, outlining responsibilities, measures for conserving biodiversity, managing natural resources, and preventing pollution.

Emergency Ordinance No. 196/2005 on the Environmental Fund, aiming to finance activities, projects, and programs for environmental protection. It's approved through Law No. 105/2006 and details the financial mechanisms for supporting environmental initiatives. Law nr. 104/2011 on Air Quality, which establishes the framework for managing air quality in Romania, setting standards for air pollutants, outlining responsibilities for monitoring and maintaining air quality, and detailing actions to be taken when pollution exceeds acceptable levels.

Emergency Ordinance No. 68/2007 on Environmental Liability which relates to environmental liability with regard to the prevention and remedying of environmental damage. It sets out the legal framework for holding operators financially and legally responsible for preventing and remedying damage to water, land, and biodiversity.
